**UK CERTIFICATE PROGRAMME**

This fourth supplement (the "**Fourth Supplement**") is supplemental to, and should be read in conjunction with, the base prospectus dated 30 June 2021 (the "**Original Base Prospectus**"), the first supplement to the Original Base Prospectus dated 29 September 2021 (the "**First Supplement**"), the second supplement to the Original Base Prospectus dated 30 December 2021 (the "**Second Supplement**") and the third supplement to the Original Base Prospectus dated 20 April 2022 (the "**Fourth Supplement**", and together with the Original Base Prospectus, the First Supplement, the Second Supplement and the Third Supplement, the "**Base Prospectus**"), in each case, in relation to the UK Certificate Programme of BNP Paribas Issuance B.V. ("**BNPP B.V.**") as issuer and BNP Paribas ("**BNPP**") as guarantor (the "**Programme**").

The Original Base Prospectus, as supplemented by the First Supplement, the Second Supplement and the Third Supplement, constitutes a base prospectus for the purposes of Article 8 of the UK Prospectus Regulation. "**UK Prospectus Regulation**" means Regulation (EU) 2017/1129 of 14 June 2017 as it forms part of domestic law of the United Kingdom by virtue of the European Union (Withdrawal) Act 2018 (as amended, the "**EUWA**") and regulations made thereunder. The Original Base Prospectus was approved on 30 June 2021, the First Supplement was approved on 29 September 2021, the Second Supplement was approved on 30 December 2021 and the Third Supplement was approved on 20 April 2022, in each case, by the Financial Conduct Authority of the United Kingdom (the "**FCA**") as competent authority under the UK Prospectus Regulation.

This Fourth Supplement constitutes a supplement in respect of the Base Prospectus for the purposes of Article 23 of the UK Prospectus Regulation. This Fourth Supplement has been approved as a supplementary prospectus by the FCA as competent authority under the UK Prospectus Regulation. The FCA only approves this Fourth Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the UK Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer or the Guarantor or the quality of the Securities. Investors should make their own assessment as to the suitability of investing in the Securities.

Each of BNPP B.V. (in respect of itself) and BNPP (in respect of itself and BNPP B.V.) accepts responsibility for the information contained in this Fourth Supplement. To the best of the knowledge of each of BNPP B.V. and BNPP, the information contained in this Fourth Supplement is in accordance with the facts and this Fourth Supplement does not omit anything likely to affect the import of such information.

Unless the context otherwise requires, terms defined in the Original Base Prospectus, as amended by the First Supplement, the Second Supplement and the Third Supplement, shall have the same meanings when used in this Fourth Supplement.

To the extent that there is any inconsistency between (i) any statement in this Fourth Supplement and (ii) any statement in, or incorporated by reference in, the Original Base Prospectus, the First Supplement, the Second Supplement and the Third Supplement, the statement referred to in (i) above will prevail.

This Fourth Supplement has been prepared for the purposes of:

- (A) amending the "Risk Factors" section;
- (B) amending the "Documents Incorporated By Reference" section to incorporate by reference the Fourth Amendment to the BNPP 2020 Universal Registration Document; and
- (C) amending the "General Information" section.

The incorporation by reference of the Fourth Amendment to the BNPP 2020 Universal Registration Document referred to in (B) above has been made to update the disclosure for BNPP. The amendments referred to in (A) and (C) above have been made to (i) reflect the updated BNPP disclosure referred to in (B) above and (ii) include a declaration concerning the audited annual results of BNP Paribas for the year ending 31 December 2021 and the unaudited first quarter results of BNP Paribas for the quarter ended 31 March 2022.

**In accordance with Article 23 of the UK Prospectus Regulation and Rule 3.4.1 of the UK Prospectus Regulation Rules, investors who have already agreed to purchase or subscribe for Securities issued pursuant to the Base Prospectus before this Fourth Supplement is published and which are affected by the amendments made in this Fourth Supplement, have the right, exercisable within two working days after the publication of this Fourth Supplement, to withdraw their acceptances, provided that the significant new factor, material mistake or material inaccuracy to which this Fourth Supplement relates arose or was noted before the closing of the offer period or the delivery of the Securities, whichever occurs first. Investors may contact the relevant distributor of such Securities in connection therewith should they wish to exercise such right of withdrawal. The final date of such right of withdrawal is 17 June 2022.**

## AMENDMENTS TO THE RISK FACTORS SECTION

"See "Risk Factors" under Chapter 5 on pages 350 to 365 of the BNPP 2020 Universal Registration Document, pages 265 to 284 of the First Amendment to the BNPP 2020 Universal Registration Document, pages 97 to 98 of the Second Amendment to the BNPP 2020 Universal Registration Document, pages 277 to 295 of the Third Amendment to the BNPP 2020 Universal Registration Document and pages 364 to 381 of the Fourth Amendment to the BNPP 2020 Universal Registration Document (each as defined below), each of which is incorporated by reference in this document."

- (e) the first sentence in the last paragraph on page 55 of the Original Base Prospectus is deleted and replaced with the following:

"Each of the documents incorporated by reference in (a) to (g) above will only be made available by the Issuer or the Guarantor to which such document relates."

## AMENDMENTS TO THE GENERAL INFORMATION SECTION

The "**GENERAL INFORMATION**" section on pages 281 to 291 of the Original Base Prospectus is amended as follows:

- (a) the first paragraph under the heading "**4. Material Adverse Change**" on page 281 of the Original Base Prospectus is deleted and replaced with the following:

"There has been no material adverse change in the prospects of BNPP or the Group since 31 December 2021 (being the end of the last financial period for which audited financial statements have been published).";

- (b) the first paragraph under the heading "**5. Legal and Arbitration Proceedings**" on page 281 of the Original Base Prospectus (which was amended by the First Supplement, the Second Supplement and the Third Supplement) is deleted and replaced with the following:

"Save as disclosed on pages 291 and 292 of the BNPP 2020 Universal Registration Document, pages 173 and 174 of the First Amendment to the BNPP 2020 Universal Registration Document, pages 102 to 103 of the Second Amendment to the BNPP 2020 Universal Registration Document, pages 127 to 128 of the Third Amendment to the BNPP 2020 Universal Registration Document and pages 323 to 324 of the Fourth Amendment to the BNPP 2020 Universal Registration Document, there have been no governmental, legal or arbitration proceedings (including any such proceedings which are pending or threatened of which BNPP is aware), during the period covering at least the twelve (12) months prior to the date of this Base Prospectus which may have, or have had in the recent past, significant effects on BNPP's and/or the Group's financial position or profitability.";

- (c) the first paragraph relating to BNPP under the heading "**6. Significant Change**" on page 282 of the Original Base Prospectus (which was amended by the First Supplement, the Second Supplement and the Third Supplement) is deleted and replaced with the following:

"There has been no significant change in the financial performance of BNPP or the Group since 31 March 2022 (being the end of the last financial period for which financial information has been published) and no significant change in the financial position of BNPP or the Group since 31 March 2022 (being the end of the last financial period for which financial information has been published).";

- (d) the paragraph under the heading "**15. Events impacting the solvency of BNPP**" on page 284 of the Original Base Prospectus (which was amended by the First Supplement, the Second Supplement and the Third Supplement) is deleted and replaced with the following:

"To the best of BNPP's knowledge, there have not been any recent events which are to a material extent relevant to the evaluation of BNPP's solvency since 31 December 2021."; and

- (e) the sub-section "16. Declaration concerning the unaudited results of BNP Paribas for the periods ending 31 December 2021" and the paragraphs thereunder (which were added to the Original Base Prospectus by virtue of the Third Supplement) are deleted.
