**Base Prospectus for the issue of Warrants and Certificates
under the Note, Warrant and Certificate Programme**

This first supplement (the **Supplement**) is supplemental to, and should be read in conjunction with the base prospectus (the **Base Prospectus**) dated 21 June 2013 in relation to the Market Access Securities Base Prospectus of BNP Paribas Arbitrage Issuance B.V. (**BNPP B.V.**) and BNP Paribas (**BNPP**) for the issue of Warrants and Certificates under the Note, Warrant and Certificate Programme (the **Programme**).

The Base Prospectus constitutes a base prospectus for the purpose of Article 5.4 of Directive 2003/71/EC as amended by Directive 2010/73/EU (the "**Prospectus Directive**"). The *Autorité des Marchés Financiers* (the "**AMF**") granted visa no. 13-292 on 21 June 2013 in respect of the Base Prospectus. Application has been made for approval of this Supplement to the AMF in its capacity as competent authority pursuant to Article 212-2 of its *Règlement Général* which implements the Prospectus Directive in France.

Unless the context otherwise requires, terms defined in the Base Prospectus shall have the same meanings when used in this Supplement.

To the extent that there is any inconsistency between (i) any statement in this Supplement, and (ii) any statement in, or incorporated by reference in, the Base Prospectus, the statement referred to in (i) above will prevail.

This Supplement has been prepared in accordance with Article 16.1 of the Prospectus Directive to the extent that such amendments have been implemented in the relevant Member State of the European Economic Area, and pursuant to Article 212-25 of the AMF's *Règlement Général*, for the purposes of giving information which is additional to the information already contained or incorporated by reference in the Base Prospectus

This Supplement has been prepared for the purposes of incorporating by reference the *Actualisation du Document de Référence 2012 et rapport financier semestriel déposée auprès de l'AMF le 2 août 2013* in English (the "**Second Update to the 2012 Registration Document**").

In accordance with Article 16.2 of the Prospectus Directive, in the case of an offer of W&C Securities to the public, investors who have already agreed to purchase or subscribe for W&C Securities before this Supplement is published have the right, exercisable within two working days after the publication of this Supplement, i.e. until 14 August 2013, to withdraw their acceptances.
